COURSE AND BIRDS

All stakes are Single Course without birdfield. Native and Released bobwhite quail in all states except no birds released for the Puppy stakes. Horseback handling will be permitted in all stakes except the Amtr Walking Derby, Amtr Walking Puppy, Amtr Walking Gundog, Open Limited Walking Gun Dog. A blank cartridge ***WILL NOT*** be fired in the Puppy Stake. 32 or 209 primer will be used for the REGION 2 Brittany Champagne Memorial Championship

PRIZES

Allan Stuyvesant Memorial Amateur Gun Dog Trophy awarded to the highest placing Brittany in the Amateur Gun Dog Stake.
Standard AKC rosettes, to all placed dogs
Points will be awarded in the Amateur Gun Dog stake for the Northeast Amateur Gun Dog Trophy and for the New Jersey Field Trial Dog of the Year for stakes open to all AKC pointing breeds.
Winner of Championship receives a custom painting by Herb Park, 200lbs Loyall dog food. Runner-up receives Saddle Bags, 160 lbs Loyall dog food.
Third place 80 lbs Loyall dog food and fourth place 40 lbs Loyall dog food.

Take the New Jersey Turnpike to exit 7A.

1. After you pay the toll, take Route 195 east to exit 16A.
2. At the exit ramp, make a right onto Route 537 West.
3. You will pass a Wawa and a McDonalds on your right. Continue on 537 past the entrance to Great Adventure on your right. Look for the light that intersects with Rt 539 and make a left onto Rt 539 south.
4. Continue down Rt 539 for about 20 minutes.
5. Once Rt 539 intersects with Rt 70 you will see a WAWA on the left, after that light you will need to bear right where rt 539 and rt 530 meet. Continue on Rt 539 south.
6. The area is heavily forested so there are no great landmarks. Look for brown WMA signs for Greenwood WMA. The main parking lot is a large dirt parking area on the right hand side about a quarter-mile south of mile-marker 18. Look for a Brittany Trial sign. If you pass the intersection for Rt 72 you went too far.
